INSTITUTIONAL FREE SHIP POLICY

Srinivasa institute of management studies was established in the year 1995 with the vision of providing quality education in undergraduate and post graduate programs for meeting the rising demands of the industry and research. The College is affiliated to Andhra University (A.U) and approved by AICTE, New Delhi. The College offers four year Under Graduate (BBA) and two Post Graduate programs (MBA, MCA).

To Encourage Sport Students, Srinivasa institute of management studies is providing financial assistance in Sports Quota Scheme. According to this Scheme, financial assistance will be provided for all sports students who do not receive any financial benefit from Government /NGO's.

The College is also providing financial assistance on merit basis in Academic Merit scheme and also economically backward class. PREREQUISITES FOR FREESHIPS UNDER SPORTS QUOTA

The College has decided to provide fee concession to all Sports Students of various courses i.e BBA, MBA, MCA in the College who are not availing Government scholarship/NGO's under Sports Quota.

A Standard procedure is followed by the College regarding the same:

- The Student who intend to avail the facility have to submit their application in a prescribed format to the office.
- The Students must be a National Sports Representative or State level Sports representative to avail this Scheme.

PREREQUISITES FOR FREESHIPS UNDER ACADEMIC MERIT

The College has decided to provide fee concession to all Merit and economically backward Students of various courses i.e BBA, B, MBA, MCA in the College who are not availing Government scholarship/NGO's under Sports Quota.

A Standard procedure is followed by the College regarding the same:

- The Student who intend to avail the facility have to submit their marks list to the office.
- The Students must have 80% marks in their academics.

PREREQUISITES FOR FREESHIPS UNDER ECONOMICALLY BACKWARD

A Standard procedure is followed by the College regarding the same:

- The students who intend to avail the facility have to submit their income certificate to the office whose annual income should be less than 2,00,000/-
